Mayor Procuk then swore in Kurtis Ziebold, Robert Bastian and Mathew Cooper as firefighters for the Village of Brooklyn Heights.

FIRE CHIEF

Chief Lasky stated that the department is now at 30 members. Twenty-five are Paramedics and five are EMT's.

The new firefighters introduced themselves to council and gave a brief background of themselves.

Mayor Procuk read an e-mail from Lt. Kevin Messich commending our Police Department, specifically Ptl. Bru and Ptl. Foote for their quick and professional response to a full arrest on Valley Belt Road on May 31st. The patrolmen were on scene using the AED's and CPR when our paramedics arrived. Lt. Messich said it is nice to know that our departments work well together.

Chief Lasky said that hydrant flushing is in full swing and the signs are posted the day before an area is flushed.

POLICE CHIEF

Chief Algeri touched on Lt. Messich's letter and thanked him for his words. He said that the AED and CPR training continues and the department will have training on June 17th at the Community Center.

Chief Algeri said that jailer Casey Archacki had resigned effective May 13, 2013.

The new Charger is being equipped and will be striped and on the road soon.

ROSBY LANDFILL

Tony Coyne and Justin Eddy are here to give council an update on the Rosby situation. They will send the power point presentation to the law director.

VFW

Fred Ramos was here to represent the VFW. They hope to have the building completed in the next 2-3 months and they would like to incorporate Sunday sales with possible hours of 9 am to 11 pm. They will try to get the issue on the November ballot.

Mayor Procuk told Mr. Ramos that we were two precincts and the vote for liquor sales passed several years ago in this area. Since then, the Board of Elections has made us one precinct and the State Liquor Control Board says we need to take a vote of the entire village.

They will need signatures of 35% of the voters who voted in the last general election on the petitions to get the issue on the ballot. Mr. Cichocki has said he would be willing to walk to get signatures for the VFW as a thank you for all they did for our Memorial Day Parade.

Mayor Procuk read a letter from Paul Schirria regarding the work stoppage on the building of the VFW. Mr. Schirria said they have run out of funds. Mr. Ramos said that the building in Independence is now in the process of selling and the project will continue.

AUDIENCE

A member of the audience asked if the stairs at the end of Belmont would be replaced. Mayor Procuk said there is no money budgeted to replace the steps at this time.

Mr. Cichocki said that he and Mayor D'Aquilla will be walking the areas of Brooklyn Hts. that edge Seven Hills and discussing joining forces to see how we can work together on these projects.

INDUSTRIAL DEVELOPMENT

Mr. Perry said the grant is moving ahead and that Solar Testing is installing the fourth and last well.

There is a very good potential tenant for the Asset Acceptance building with an \$8 million dollar a year payroll and also a solid prospect for the Honeywell building with a \$10 million dollar a year payroll.

At this point he has no update on the GEIS property.

Mrs. Guilfoyle said she has a disabled resident who qualifies for the lawn cutting program with a doctor's note but not until August when her children leave for college. She asked if the cost could be prorated because she would only be getting half the season.

BUILDING DEPARTMENT

Mr. Socoloff said that the point of sale inspections, rental inspections, re-inspections and commercial inspections were quite brisk for the month of May and he sees the same for June.

There are four new houses on Marko Lane that are either now occupied or ready to be occupied.

Mr. Socoloff said he is answering complaints about high grass and property maintenance also.

Mr. Walsh asked how important are point of sale inspections and Mr. Socoloff said that they give the buyer a sense of comfort to know that someone has checked the home since most inspections cost between \$400 and \$500.

ENGINEER

Mr. Henry would like a Parks committee called to discuss the park drainage issues and the chain link fence.

There are several ordinances up for consideration tonight.

- NEORSD ordinance which allows us to draw money from the Storm Sewer Fund to do repairs.
- The ordinance allowing us to put in the pump station in the park to tie in the sewers and \$40,000 of that will come from the Sanitary Sewer Fund.
- The concrete repairs on Resource Drive
- The municipal parking lot repaving. Since the bids were lower than estimated we will have additional funds to apply to the community center ADA improvements.
- We need to have an ordinance on our books by July regarding Fair Housing in order to apply for funding and grants.
