- Up \$88,000 through February in the General Fund
- Received about \$100,000 in property tax
- Income tax through February has been steady
- Cash disbursements for February were \$462,000 and will be about the same for March
- R.I.T.A income drop for March was \$251,000 which is down
- Other communities are down also and R.I.T.A has no good explanation for the low collections. They believe it will smooth out over the next few months
- Year-to-date we are down \$342,000 in R.I.T.A collections
