Councilman Lahiff, speaking to Mr. Clymer, said that at the September finance meeting Mr. Clymer projected that if we spent the 2017 full budget we would end the year with a deficit of \$750k and if we spent 3% below the budget we would have a \$542k deficit for the year. Since the report we've lost a major employer. Do you still think we'll have a major deficit for the year?

Mr. Clymer responded that the one dynamic that he can't control is the R.I.T.A. receipts and that has continued to come in above expectations. He expects us to spend more than we bring in for the rest of the year but to quantify it would be difficult without knowing the R.I.T.A. receipts for the rest of the year. It is important to keep an eye on that information as the year progresses.

#### **ECONOMIC DEVELOPMENT**

- We were turned down for the FEMA 2017 grant for a new fire truck. Our truck is only 22 years old and they give the grants at 25 years.



- Issue 1 Proposed Constitutional Amendment: Rights for Crime Victims
- Issue 2 Proposed Law: To require state agencies to not pay more for prescription drugs than the federal Department of Veterans Affairs and require state payment of attorney fees and expenses to specific individuals for defense of the law

Dear Mayor Procuk

Since 2015, the County has funded a program to assist communities with roadway maintenance. This program, as passed by County Council, is currently limited to four years from 2015.

Communities within Cuyahoga County may now apply for grant funding from the Department of Public Works for reimbursement costs of materials used in performing routine maintenance of County routes. Prioritization will be given to routine maintenance work that will extend the useful life of the pavement.

Municipalities wishing to seek reimbursement for maintenance work in 2018, should complete the attached form outlining the proposed work, County Road name, termini, estimated cost splits (labor/materials), etc. Communities selected for material cost assistance will be reimbursed after work is completed, inspected and invoices sent to the County. We look forward to assisting your community in extending the pavement life through preventative maintenance.

In order to submit a request for consideration for funding in the 2018 maintenance program, complete the appropriate forms, and return to the county by October 27, 2018. The Department of Public Works will evaluate all requests and will respond back by January 2018. 

Al Martin, in his 21st year at the helm of the Cuyahoga Heights Football Program, has reached the 200th career victory milestone with his team's win over **Berkshire High School**. Coach Martin has been the head coach of the Redskins since the 1997 season and has a career record of **200-44**.
