CORRESPONDENCE

Mayor Procuk read a letter from the Board of Elections regarding the use of the Community Center for the General Election on Nov. 4, 2020 with set up on Nov. 3rd. They are asking him to sign an agreement (due to COVID-19). Per Law Director Dowling, the mayor may sign the agreement and mail it in.

- Chelsey Kovar asked about the "no dogs in the park" rule and if it was an insurance issue or a
 waste issue. Mayor Procuk said the law has been in effect for as long as he can remember and
 though the issue has come up before the law has never changed. Mr. Lahiff said that about four
 years ago it was a 3-2 vote to keep it as is.

SERVICE

- MOTION: Mr. Lahiff moved to pay Stanley Convergent Security Solutions, Inc. \$2,961.00 for the annual service contract of the Fire Systems from 8/1/20 thru 7/31/21. Seconded by Mr. Blados Motion carried 5-0
- MOTION: Mr. Lasky moved to pay Droba's Auto Body \$3,874.40 for repairs to the 2005 F-350 truck bed. Seconded by Mr. Blados Motion carried 5-0
- Mr. Hatgas asked for a motion to purchase a lift gate for the F-350 but there was no response.
- Mr. Hatgas asked for a motion to enter into a 1 year contract with Verizon Connect for GPS for the Service Department vehicles. The cost would be \$2,370.60. Mayor Procuk said this would gauge the speed of the trucks and track where they are. He said that the Police department is monitored by the MDT's and the Fire Department has to notify dispatch when they take a vehicle out. He said he would see if this could be covered by the COVID-19 monies. Mr. Blados would like to table this to the next meeting so they can research it further.
