MOTION: Mr. Foote moved to approve the minutes as distributed of the January 8, 2019 and January 15, 2019 regular meeting of council. Second by Mr. Walsh Motion carried 5-0

#### CORRESPONDENCE

- Letter dated Jan. 11<sup>th</sup> from Tim Boyko, Chairman of UH Parma Board, stating that UH President Peter Bergman resigned and they are searching for a new president.
- Letter dated Jan 10<sup>th</sup> from NOACCA stating that Brooklyn Heights is the recipient of a NOACA grant (80% funding) for a new Community Services vehicle. The village will be responsible for the other 20%.
- Letter dated Jan. 18<sup>th</sup> from Chuck Kuiper of NOPEC stating that the village is the recipient of a NOPEC Energized Community Grant in the amount of \$7,310 for 2019. This grant is to help defray costs of implementing energy efficiency.
- Letter dated Jan. 25<sup>th</sup> from County Executive Buddish stating that the village is the recipient of the County 50/50 grant program for 2020. This grant is for the resurfacing of Spring Road from Van Epps to the north corporation line. The county will reimburse 50% of the cost up to \$250,000. Mayor Procuk thanked Engineer Mike Henry for working to get this grant.

## FIRE DEPARTMENT

- Chief Stefanko informed council that the department has begun the upgrades to the station for the Regional Dispatch that will go into effect in June.
- Pulled nine (9) SCBA tanks that are expired in January and February and will pull another eight (8) from service in March and April. The department has applied for a FEMA grant to replace the tanks but won't know until June if we get the grant. Garfield Heights Fire Department received a FEMA grant last year and replaced their tanks so they are offering their old bottles to us. They are able to give us sixteen (16) tanks and we would need a Memo of Understanding from the administration.

#### **COMMUNITY SERVICES**

- AARP Tax prep for low income and Senior citizens. February 25<sup>th</sup> and March 25<sup>th</sup>.
- Mrs. Guilfoyle will attend the NOACA grant meeting tomorrow
- Blood Drive on March 15<sup>th</sup> from 1p-6p in the Community Center
- Spring Art-in-the-Park will be on March 26<sup>th</sup> & March 28<sup>th</sup> from noon 2p in the Community Center

#### POLICE DEPARTMENT

- MOTION: Mrs. Presot moved to pay Firehawk Automotive \$1,082.45 for repairs to the 2014 Dodge Charger for front end repairs, front end alignment and brakes. Second by Mr. Foote. Motion carried 5-0
- Two new part-time officers were sworn in at the committee meeting. Jacob Ross of the Valley View Police Department and Kevin Stack of the Cuyahoga Heights Police Department.
- The renewal of the Animal Control contract is on the agenda of ordinances tonight. In 2018 we budgeted \$6500 and came in under budget. The monthly cost is increasing so Chief Algeri budgeted \$7,000 for 2019 if the ordinance is approved. No trapping is done without the approval of the chief.
- The department Breathalyzer is 28 years old and is obsolete. The company will no longer service it. A new unit costs about \$11,000. Valley View sold us their obsolete machine for \$200 and we will use the parts to keep ours running for a few more years.

#### SERVICE DIRECTOR

- The NOPEC grant with the carryover from 2018 will total about \$9,900. Mr. Hatgas will get
  quotes for new windows for the Community Center and doors for the Municipal Building. Will
  need a Building Committee meeting to discuss how best to use the funds.
- MOTION: Mr. Walsh moved to pay Signal Service \$1,208.77 for repairs done to several village owned lights along Rt. 17. The work was done in September, 2018 but not billed until January, 2019. Second by Mr. Blados Motion carried 5-0
- Mr. Hatgas told council that the company that originally came out to clean the ductwork in the Community Center found mold and was not certified. MOTION: Mrs. Presot moved to have Precision Environmental remove the mold from the ductwork at the Community Center at a cost of \$2,700. Second by Mr. Walsh Motion carried 5-0
- MOTION: Foote moved to pay Gillingham Ford \$1,330 for repairs to the F-550 air conditioning unit. Second by Mr. Lasky Motion carried 5-0
- Mr. Hatgas will dispose of the 2012 Dodge Charger at a cost of less than \$1,000.
- Mayor Procuk asked how our road salt situation is and Mr. Hatgas said that as of tomorrow we
  will have a full bin. We are obligated to purchase a pre-determined quantity of road salt through
  our contract.

 Mayor Procuk complemented the Service Department on a job well done during the Polar Vortex and the ensuing snow storm we had. He said there were many compliments from both businesses and residents.

#### **ENGINEER**

- The Van Epps gas main will be installed shortly. Plans have been approved.
- Received \$250,0000 grant from the county to fix Spring Road
- 2020 will bring additional grant money from Ohio Public Works Commission to help the county grant go further.

#### **BUILDING INSPECTOR**

- Had a few point of sale inspections
- Pushing to get the VNA in and GrafTech on Keynote Circle.

#### LAW DIRECTOR

- The Public Hearing went well. Mr. Dowling thanked the representatives from NIDEC and Geis for attending and answering the questions presented. We will be going forward with the rezoning.
- The County has asked if we want to take a foreclosure property into our land bank, but since there is a structure on the property he said we won't.
- There is property on Van Epps that we have received bids on. Our Assistant Law Director Sheila will be working on this.
- Mr. Dowling will be out of town the next few meetings so Sheila will attend.
