CORRESPONDENCE

- Mayor Procuk read a letter from Cleveland Councilman Tony Brancatelli regarding semi's driving through the residential neighborhood at Spring Road to get to I-176. They have signs up but would like Brooklyn Hts. to put "no through trucks" signs at Van Epps and Spring.
- Read a letter from Bratenahl Mayor Licastro regarding the Mayor's and City Managers meeting where they are forming a Traffic Safety Committee which he will chair.
- Received a note from Superintendent Evans regarding the Hilltop school bus route. They are still looking at this to determine a solution to the problem.

AUDIENCE

- Mayor Procuk read the Proclamation to Jim Cassidy upon his retirement from the Police
 Department and his service of 38 years to the Village of Brooklyn Heights. Congratulations Jim
 Cassidy.
- Our tax administrator, Greg Cingle, introduced Matt Mau from R.I.T.A. to give a brief overview
 of what R.I.T.A. does for the village. He said in 2019 we saw an increase in our municipal income
 tax receipts of 27% due to the .05% increase in municipal tax in 2018.

Letters were sent out to delinquent taxpayers that totaled greater than \$32,000 and they have collected \$13,000 so far. They will continue to make the effort to collect the tax liability due us.

In 2018 R.I.T.A. took legal action on two cases owing \$8,000 and they collected \$6,600 of the monies owed through the legal action.
