## **MAYOR'S REPORT**

- With the new businesses to our village we are in need of the Housing Council again. The council consists of seven (7) members. Two (2) are appointed by the Mayor, two (2) are appointed by council and one (1) is appointed by the Planning Commission. As a group, the five (5) appointees then appoint two (2) additional members. Presently, Cookie Krizmanich, Coleen Dankle and Wendy DiFranco are on the board and Mayor Procuk will check with them to see if they would like to continue. This must be done by March 31, 2021.
- When voting on the ordinances tonight, Mayor Procuk would like council to consider paying cash for the Service Department truck and cash for the police department vehicle equipment which would total about \$122,000. They would be spending money from the BWC deposit of \$271,000 which we received last fall and was deposited into the Capital Fund leaving approximately \$122,000 in the Capital Fund. They can finance the three (3) police cars and make two (2) payments in 2021, four (4) payment in 2022 and 2023 leaving the balance to be paid in 2024.
