

- Tiffany from RTA responded to Mayor Procuk regarding the requested route change for a bus along Granger Road. This was requested by several businesses in the Valley Belt and Lancaster Road areas. She will draft the request and will gather letters of support from other businesses that are supporting the route change request.
- E-mail from Brian Loebick of South Street the fence along their border will not last another year. The fence belongs to the village and he would like to offer his services to install the fence if the village supplies the materials. Mayor Procuk turned this over to Service Director Hatgas who said they will take a look at it in the spring. He also gave it to the Park Ad Hoc committee to discuss at their next meeting.
- The Cleveland Metroparks Zoo will hold their annual Wild Winter Lights Drive-Through beginning Nov. 17th. This is sponsored by NOPEC and reservations are required. Information can be found at clevelandmetroparks.com/zoo
- Councilman Walsh thanked Mayor Procuk, Chief Meade, Chief Stefanko and Asst. Chief Lasky for a safe Halloween. Ms. Kovar said the same thing.

POLICE CHIEF

- MOTION: Mr. Blados moves to pay Firehawk \$1,393 for front end work done on the 9 year old chief's car (Charger with 130k miles) Seconded by Mr. Lasky Motion carried 5-0
- Chief Meade will be attending Chief classes in New London, OH from Nov. 15th thru Nov. 20th. Lt Zakrajsek and Sgt. Dzik will be in charge.
- Chief Meade said the police hiring is on schedule for Dec. 1st. He was very impressed with the list of candidates.

FIRE CHIEF

- Chief Stefanko asked for a motion to ratify a purchase made for identification labels for the new SCBA's and masks. MOTION: Mrs. Presot moved to ratify the payment of \$1,075.44 to IdentiFiresafety.com for luminescent labels for the SCBA's & Masks. Seconded by Mr. Walsh Motion carried 5-0
- The FEMA18AFG has been finalized and we received a check for \$7,216.19 from Cuyahoga County so this project cost the village zero dollars.
- Received a grant for \$20,246 for a new LUCAS System and we will receive \$5,000 as a trade-in on the old system. Also received a grant from the State of Ohio for \$3,000 which can also be applied. This is also eligible for CARES ACT funds. An ordinance to make this purchase will be written and presented at the November 17th meeting so this can be done before the end of the year.
- Mr. Lasky asked how much money we have from the CARES ACT and was told about \$95,000.
 Mayor Procuk said Mr. Frank has justified the use of all the CARES funding.

SERVICE DIRECTOR

- MOTION: Mr. Lahiff moved to pay Knowles Municipal Forestry \$4,560 from the Cuyahoga County Tree Grant. Seconded by Mrs. Presot Motion carried 5-0
- Mr. Hatgas said we've already spent \$5,814 for a total spent of \$10,374 leaving \$1,875 for a landscape architect and Mr. Henry for the park.
- Mr. Hatgas will get Mr. Dowling the information to write an ordinance for the salt spreaders for the Nov. 17th meeting.
- Mayor Procuk asked if the City of Cleveland has done anything about the asphalt repairs needed on Van Epps and Mr. Hatgas said "not yet". He will call them again tomorrow.
- Mayor Procuk noted that all the election gear has been picked-up and the building has been sanitized and is ready if the school should need it again.

COMMUNITY SERVICES

- Forty seniors drove through the Community Center parking lot to receive a Halloween treat from the Brooklyn Senior Center. Additional Drive-thru events will be on Nov. 18th and Dec. 16th.
- The snow removal program has fifty-six (56) signed up
- Project Hope Christmas Wish Tags will be taped to the windows in the lobby of the Municipal Center. A box will be there to accept the gifts.
- Although there will be no Remembrance Celebration, the department will make ornaments for those wishing to remember their loved ones.
- Christmas Art-in-the-Park will be held via ZOOM on Dec. 23rd and Dec. 30th.

SOCCER

RECREATION DEPARTMENT

- We are preparing for a basketball season beginning in January. Much will depend on the county and if we go into purple.
- We have four (4) teams with 5 or six players. We may combine all the kids from Brooklyn Heights, Valley View and Independence to try to form at least two teams in each age group.

- The water main project is being tested and will try to get the homes connected the week of Nov. 16th.
- Asphalt paving project is done and concrete will be the end of the week.

- The application for the Ohio Public Works grant will be submitted tomorrow. This will be to replace and reconstruct Spring Road in 2022, if awarded the money. We already have \$250,000 which is a 50/50 grant.
- ODOT is looking to modify the eastbound ramps from Brookpark Road and the Jennings Freeway (I-176) making them two completely separate ramps. This work would begin in 2021 and they are also making plans to fix the existing bridge with a grind and repave from Tuxedo to W. 130th. This will take several years.

LAW DIRECTOR

- No Report
- Mayor Procuk said that the ad in the Sun News for the land on Van Epps Rd. will be less than \$1,000 and will run for five (5) consecutive weeks. A successful bid would need two-thirds of council to act on it. Both DieMatic and a Jones family member want to bid.

BUILDING

- J.V. Janitorial work on their new building on Resource Dr. continues.
- The roof is being worked on for the National Weather Service. Extended their temporary occupancy permit.
- The 2nd floor ICE project continues
- Several small businesses are moving in on Hayes Drive and we (Building and Fire Depts.) are requiring them to upgrade the fire systems as they move in.
- The tennis courts at 322 Little Creek Parkway have been removed and the ground has been graded and seeded.

CLERK / TREASURER

- Will be closing October on Thursday, Nov 5th.
- First R.I.T.A. drop for November was \$484,000, up about \$30,000 from October 2019.
- Deposited \$10,000 in the Retiree account (203), \$45,000 in the Incentive Account (204) and 5% -\$23,528 in the Capital Improvement Account.
- The audit continues.
- Mayor Procuk gave kudos to Mr. Hatgas and Mr. Frank for putting together the NOPEC grant.
 We've spent \$7,222 and have \$438.50 to rollover into next year.
- We received our second BWC give-back in the amount of \$74,454
