• MOTION: Mr. Walsh moved to pay Rush Truck \$1,511.39 for repairs to 2015 International. Second by Mrs. Presot Discussion: Mr. Lasky questioned the 86 point inspection report by Rush Care Express Center. He asked why it went back and Mr. Hatgas said the PTO and mirrors were not working. He stated that, line item 15 "check door glass and mirror control" was checked as working and now we are having it fixed.

Mr. Hatgas said that if council approves payment of the invoice he will question this with their service department prior to actually paying the invoice.

Mr. Lasky questioned if the PTO, Joy Stick and mirrors were under warranty and Mr. Hatgas said that the PTO and Joy Stick were not part of the original truck but was added by their vendor and the mirrors were not under warranty because someone tampered with them. Mr. Lasky asked if our in-house mechanic, Mike Florjancic, had looked at this problem and Mr. Hatgas said he did not because he (Mr. Hatgas) thought they would be under the warranty. He is disappointed in this company. Mr. Walsh suggested looking into Guaranteed Truck Service and one on Acorn Dr. in Macedonia. Mr. Lasky would like to think about spending our money elsewhere. He suggested American Fleet on Canal Road. Mr. Hatgas said he will be in contact with their service manager tomorrow and will let council know the results.

Mr. Hatgas asked to move to the ordinances. Mr. Hatgas gave the recommendation of Concord Road Equipment Ordinance 63-2020.

ORDINANCE 63-2020- AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND/OR VILLAGE CLERK TREASURER TO ENTER INTO AN AGREEMENT WITH CONCORD ROAD EQUIPMENT MFG. INC. FOR THE PURCHASE OF A SWENSON EV150 SALT SPREADER FOR THE VILLAGE OF BROOKLYN HEIGHTS

Discussion: Mr. Lasky asked why this recommendation and Mr. Hatgas said that Concord has always been very good to the village and we have a great working relationship with them. Mr. Lasky said that Mr. Blados spoke very highly of Cenweld and we would save about \$2,200 for the same piece of equipment. Mr. Hatgas said we have dealt with Cenweld and said they have not hurt us. Mr. Lasky wanted to vote for Cenweld but there are only four members of council here tonight. Concord has one in stock and Cenweld would have to bring it down from Wisconsin. Councilman Blados will be on the call momentarily. Mr. Lahiff would like to get Councilman Blados' input. Mr. Walsh suggested they go to the ordinance because council asked Mr. Hatgas for his recommendation and he gave it but now we are nitpicking. Mr. Walsh feels confident in Mr. Hatgas's decision making and Mr. Lahiff said that council has to spend the money. Mr. Walsh said that we never question the police or fire department like they do the Service Department and now they'll be spending another half hour discussing the same issue. Mr. Lasky said that Cenweld has the equipment put aside for us and we can save \$2,200 which could be used toward another mower or other piece of equipment. Councilman Blados joined the meeting at this time. Mr. Blados said he did speak highly of Centweld but if Mr. Hatgas wants to go to Concord he would agree. Mr. Hatgas and the Service Department would be comfortable with Concord and for the difference of \$2,200 it should be fine. Mr. Lasky conceded that he would go along with what the rest of council wants to do. Mrs. Presot asked Mr. Hatgas if we are sure that we can load the V-box into the truck and that another piece of equipment will not be necessary.
