MOTION: Mr. Lahiff moved to excuse Mr. Walsh (business meeting) and Mr. Foote (vacation) from the meeting tonight. Second by Mr. Selig Motion passed 5-0

Mayor Procuk will go out of order tonight and hold discussion on Ordinance 65-2013 up for consideration tonight.

They were told that the age would be geriatrics and the building is the old Asset Acceptance Building on West Resource.

# **AUDIENCE**

Paul Baracz of Schaaf Road asked council to address the parking of trucks on his property at 900 Granger Road. He stated that he received a letter from the Building Inspector stating that it does not conform with the zoning of retail property. Mr. Baracz feels that he should be allowed to continue the parking of the trucks as the rental of the space helps him pay the taxes on the property. He said that he has been doing this since the 70's and the zoning ordinance went into effect in 1994 so why are they now questioning it. He feels a reasonable solution to this would be for council to enact a resolution stating that the trucks can continue to be parked at 900 Granger Road until such time as the property is either

developed or sold unless they change the zoning from retail. He stated that there is no retail anywhere in Brooklyn Hts. He said that in front of the Fogg Building the trucks are parked all day and all night.

It was explained to Mr. Baracz that the other violators have received the same letters. All he wants is to be grandfathered in. He said he has tried to get his taxes changed from residential to commercial but with no luck.

Mr. Cichocki told Mr. Baracz that council will hold a committee meeting to discuss possible solutions. A woman in the audience asked what the complaint is. Is it the sight of the trucks or the traffic? Mayor Procuk answered it is the sight of the trucks. He also said that others have had to move their trucks off of their property and she asked what the complaints were for them. Mayor Procuk said they were not in compliance of our ordinances.

Mayor Procuk said that he deals with this type of problem on a daily basis.

# **DEPARTMENT REPORTS**

# SERVICE DIRECTOR

Mr. Hatgas said that the drainage work on Diamond 2 will begin tomorrow (Aug. 7<sup>th</sup>).

There was \$600 worth of damage to the soccer goals. Thanks to two businesses in the village who picked up the goals and then delivered it back to the park after another village business repaired them very economically for us.

Mr. Cichocki asked if we caught the vandals and was told no.

MOTION: Mr. Black moved to pay \$3,217.02 for the repairs to the Community Service Department. Second by Mrs. Presot Motion passed 5-0

# **FIRE CHIEF**

Chief Lasky told council that we received a FEMA grant in the amount of \$35,000 to purchase new equipment. The cost to the village will be \$1,700. In speaking with Safety Chairman Cichocki it was decided to discuss the ordinance at this evenings meeting.

MOTION: Mr. Black moved to pay \$1,404 to Underwriters Laboratory for the annual ladder testing. Second by Mrs. Presot Motion passed 5-0

Chief Lasky told council that on October 12<sup>th</sup> there will be a 5K/1 mile walk held in the village with the proceeds to benefit the Park Board. Parma Hospital and University Hospital are the two big sponsors at this time.

There will be a meeting of the Safety Committee on Tuesday, August 13<sup>th</sup> at 7 pm to discuss the purchase of a new gator for the fire department

#### POLICE CHIEF

Chief Algeri told council that we received a check for \$318.67 a restitution from a SWAT incident that happened in 2011.

MOTION: Mr. Black moved to pay \$2,197.05 to Bedford Hts. jail for the month of June. Second by Mr. Cichocki Motion passed 5-0

The copier in the police department no longer works. Chief Algeri said he had money in his budget to

purchase a new machine. He had quotes from Blue Technologies and Meritech.

MOTION: Mrs. Presot moved to pay \$3,850 to Meritech for a new copier for the police department. Second by Mr. Black Motion passed 5-0

Chief Algeri attended a School Safety meeting on July 23<sup>rd</sup>. He commended Mr. Evans on the work that he has put into this effort. They will meet at least three times a year. There will be a safety drill utilizing the safety forces and the surrounding communities on NEOEA day in October. Chief Algeri said that the new superintendent is Joe Bergant and he comes from Chardon Schools so safety is of utmost importance to him. Mr. Evans has applied for a grant to put a School Resource Officer in the schools.

Ford Interceptor Utility is in service. The old Crown Vics and three obsolete Toughbook's will be put on E-bay.

The new Mobil Data Terminals are in service.

Our officers will get training with Cuyahoga Heights Police next week. They will be utilizing the Mobile Police Academy from the Ohio Attorney General's office. There are two trailers: a Driving Simulator and Firearms training.

Chief Algeri told council that there have been several auto (4 older GM models in the last few weeks) and bicycle thefts in the area. He said that one suspect was arrested but while he was in jail, another bike was stolen so it looks to be more than one thief. He admitted to taking two bikes from Brooklyn Hts. but would not admit to any from Seven Hills.

#### **COMMUNITY SERVICES**

Mrs. Guilfoyle stated that the blood drive will be held on August 29<sup>th</sup> in the Community Center.

On September 19<sup>th</sup> Cuyahoga Hts. Schools will host the senior citizens for dinner and the department will transport our seniors.

Our department will also be transporting the Pre K children during the middle of the day.

Mrs. Guilfoyle said that the website is moving along.

#### **ECONOMIC DEVELOPMENT**

Mr. Perry said that the progress on the village property on Schaaf Road is moving along.

The Asset Acceptance building on W. Resource will be occupied by Haven Behavioral HealthCare.

He has been working with Omni to get the Honeywell Building filled.

The Economic Development portion of the website is just about complete and they hope it will launch soon.

#### **ENGINEER**

Mr. Henry stated that the back parking lot of the municipal building will be delayed to next week.

He attended the Pre-construction meeting with ODOT for the Granger Road resurfacing from Valley View to Tuxedo. The project is scheduled to begin on August 12<sup>th</sup> and should be completed by the end of October. At this point they don't know if they will begin at Tuxedo or in Valley View.

The drains on diamond #2 should be completed within two days (by the end of business Thursday).

#### **BUILDING INSPECTOR**

Mr. Socoloff stated that there are a lot of residential permits being pulled. Also several companies are making capital improvements.

The number of complaints being filed is high and he will prioritize them and get to them as he can.

Mrs. Presot asked if there was anything new on the Church on Brookpark Road. Mr. Socoloff said he has not had any contact from them in some time. Their variance will be expiring soon so he will give them a heads up.

Mayor Procuk said that they will not be pursuing the Schuckerts to go before the ARB because the tree house is already build and is a moot point.

#### LAW DIRECTOR

Mr. Dowling will attend the Community Reinvestment Committee review at the County Auditor's Office on Monday.

# **CLERK-TREASURER**

Mr. Clymer reported that the General fund is up \$99,526.

He said that the secretary (Ruth Blogna) from Mr. Dowling's office lost her husband recently and he and Valerie Snyder went to the wake. He read a thank you note from her.

## RECREATION DIRECTOR

Mr. Presot was unable to attend but he gave his report to Mayor Procuk.

Chief Algeri said they would take care of it, but asked council to look at some rules governing street closures. Mayor Procuk suggested it be put in the Safety Committee meeting to be held Tuesday, August 13<sup>th</sup>.

Mayor Procuk received an invoice for \$40 for the annual dues for the Mayor's Association.
