AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND/OR CLERK/TREASURER TO ENTER INTO A CONTRACT WITH TECTRONIC OFFICE PRODUCTS SALES & SERVICE (TOPSS) TO MAINTAIN AND SERVICE ALL COMPUTER RELATED EQUIPMENT AND PROVIDE TECHNICAL SUPPORT FOR THE VILLAGE OF BROOKLYN HEIGHTS' SOFTWARE SYSTEMS

WHEREAS, it is necessary for the Village to employ a firm to maintain and service all computer related equipment and provide technical support for its operating and software systems; and

WHEREAS, the Village desires to enter into a Contract with Tectronic Office Products Sales & Service (TOPSS) for said maintenance, service and technical support for its operating and software systems.

THE VILLAGE OF BROOKLYN HEIGHTS HEREBY ORDAINS THAT:

Section 1. That the Mayor and/or Clerk Treasurer are hereby authorized to enter into a Contract with Tectronic Office Products Sales & Service for the period of one year commencing January 1, 2018 to December 31, 2018, in an amount not to exceed \$7,830.00 (according to the terms contained in said Contract, attached hereto as Exhibit A).

WHEREAS, the Village of Brooklyn Heights desires to enter into an agreement with Chagrin Valley Engineering, Ltd., with Michael E. Henry PE as Municipal Engineer, for engineering services beginning January 1, 2018.
