MOTION: Mrs. Presot moved to approve the minutes of the March $3^{\rm rd}$ regular council meeting as distributed. Second by Mr. Lahiff Motion carried 5-0

- Mayor Procuk said that the Community Center is closed and will be kept secure until further
 notice. The two March rentals we had have cancelled and all activities held in the Community
 Center have been notified that the center is closed. The Service Department will turn off the
 refrigerator, freezer and ice machine.
- With the kids off from school they have been gathering at the basketball hoops in the park. With the restriction of the number of people allowed to gather (national # is 10) Mayor Procuk has authorized that the hoops be taken down until further notice.
- Our Fire & Police services are essential and they will continue to keep our streets safe and work to save lives. Both departments have the needed personal protective equipment (PPE) to continue with their jobs.
- The police department will not be stopping to engage in general conversation with residents and will maintain the safe distance when possible. They will do their job to maintain a safe and peaceful environment for our residents.
- The Fire department cannot always maintain the safe distance as they work on a call but they will be vigilant in using the PPE and sanitizing the vehicles after each run.
- The Service Department has been given the opportunity to stagger start times to clean and sanitize the buildings and vehicles. They were advised to have one (1) in the vehicle because of the safe distance ruling.
- Community Services will continue to transport our seniors for medical, religious and grocery shopping as needed and this is changing by the minute and so are the hours.

- Jerry Dowling handed out an informational letter to council as to how to deal with the
 administrative meetings and the sunshine laws in these troubled times. This is in reaction the
 state of emergency that has been declared. He asked council to look it over and it will be
 discussed at an Ordinance Committee meeting next Tuesday, March 24, 2020 at 6:00 pm.
 Ordinance Committee meeting to "discuss the regulations with respect to employee pay and
 fringe benefits and public meetings in order to respond to the COVID-19 Corona Virus
 pandemic."
- Mayor Procuk asked for a Safety Committee meeting next Tuesday, March 24th. They will ask for a "memo of understanding" from the union to help ease the scheduling. The eligibility promotional list expires on April 21st and they will need to test. The Safety Committee meeting will be held at 6:15 to consider restructuring of the police department going to ten (10) or twelve (12) hour shifts.
- These committee meetings will be followed by a special council meeting to consider any legislation at 7:00 pm.
- Mayor's Court will be suspended until June and the prosecutors are saying that all citations will be "no point misdemeanors" and it will allow them to pay the waiver by mail. If a case must be heard it will be assigned to Parma Municipal Court to be dealt with there.

Mr. Frank said that he has decided to have his department work split shifts so they are not all in the office at the same time. Mayor Mike said we don't have the ability to tell someone to stay home and we don't have the ability to pay that person to stay home. If the employee has the ability to do their job from home that can be set up. We are working towards closing the building and limiting who comes in. Mr. Frank said the office girls are using sick leave to be paid.

Our part-time fire fighters have been told that if they have a fever they are to stay away from the station.

There being no further business to come before the council, it was moved by Mr. Lasky seconded by Mr. Blados that the meeting be adjourned.
