An Emergency Ordinance – not adopted by council (need four yes votes)

LAW DIRECTOR

- Patrolman Joe Coyne is now in National Guard training and will be gone for six (6) months.
- We need to develop a Military Pay Policy
 - 1. ORC says we pay the first twenty-two (22) day's pay
 - 2. We have the option of paying the difference between the military pay and his Brooklyn Heights gross pay or pay him \$500 a month
 - 3. If we pay his full salary he would be responsible to hand over his military pay
 - 4. Council can choose how we pay him or they can let the Clerk-treasurer make the decision
- Mrs. Presot feels that the policy should reflect the different pay scales of each employee and Mr.
 Dowling said that the ORC is specific as to how the pay is given.
- A decision must be made so Val can pay him this week.
- Mr. Foote asked what other costs are associated with this and Mayor Procuk responded "overtime".
- We are in the process of paying the first twenty-two (22) days but it is coming to an end.
- Mayor Procuk suggested calling a special council meeting this week so they have the numbers.
- Mr. Lasky feels that they should allow Clerk-Treasurer to make the decision.
- Mr. Foote feels that we should pay his full salary because he is fulfilling an obligation for the greater good. Mr. Coyne still has his daily obligations and expenses to pay.
- Mr. Dowling said they are trying to develop a policy and he will be coming back regarding accruing vacation and sick leave.
- Mr. Blados called a Wage & Salary meeting for Thursday, March 21st at 6:30 pm to continue this
 discussion on a Military Leave Policy including all the benefits. They will ask Valerie Snyder to
 attend this meeting also.
