CORRESPONDENCE

Email to Chief Meade from Ptl. Jack Wilkins informing the chief of his resignation from the Police Department effective December 11, 2020.

Read the responding email dated December 10th from Chief Meade to Ptl. Jack Wilkins accepting his resignation effective December 11, 2020. He informed Ptl. Wilkins that he owes the village one day pay for Christmas which he has already used. This will be deducted from his final paycheck. He also informed Ptl. Wilkins that he could purchase his bullet-proof vest at a cost of \$185. Ptl. Wilkins is joining the Lakewood Police Department.

Email dated December 15th from Service Director Ed Hatgas informing council of his upcoming shoulder surgery on December 18th. He will use his vacation and then sick time. He informed them that he can be reached by phone and that Foreman Chris Triscari will be in charge.

Email dated December 7th from NOPEC regarding the Sponsorship Grant. The village has been awarded \$1,000 for 2021. Mr. Mark Lasky thanked Park Board Treasurer Gary Suchocki, Clerk/Treasurer Frank, Mrs. Guilfoyle and Donna Algeri for their help in obtaining the grant.

SERVICE DIRECTOR

Mayor Procuk read a memo from Service Director Hatgas requesting a motion. MOTION: Mr. Blados moved to pay Presot Masonry and Construction \$1,000 for repairs to the Community Center for damage done by Kimble. To be reimbursed by Kimble. Second by Mr. Lahiff. Motion carried 5-0

CLERK/TREASURER

- Mr. Frank closed the month of November with a surplus of \$251,000.
- \$10,000 was deposited into the Retiree Fund and \$45,000 into the Economic Development Fund.
- We received a large check from the City of Cleveland for the W. 5th Street work and a portion of that will pay the Chagrin Valley Engineering invoice.
- We are operating at 10% under budget for 2020.
- The second R.I.T.A municipal income for December was \$243,000 bringing our total Municipal Income for 2020 to \$6,352,461 which is about \$212,000 over our predicted amount.

The Exit Audit interview went very well and Mayor Procuk said it was the cleanest audit he has seen. There are 54 outstanding checks with some being almost 20 years old making reconciling the accounts difficult. The auditors pointed this out and Mr. Frank will try to clear this up in 2021. It will go into an Unclaimed Funds account. If the funds remain unclaimed then the money will go back into the General Fund.

MAYOR'S REPORT

- Mayor Procuk said we are \$430,000 ahead of 2019 so we are finishing the year in good shape.
- He reminded council that we will be swearing in two additional police officers at the January 5, 2021 meeting.
- He has prepared a Resolution and will call a special meeting once we receive the expected \$277,316 BWC check. He would like to put the funds into the Capital Improvement Fund. Hopefully we will have the money before the end of the month.

PARK AD HOC COMMITTEE

- The committee met to discuss the regrading of the upper park small playground and new equipment. The also discussed the basketball courts and tennis courts.
- Mr. Henry has been working on grants
- Mr. Blados thanked all who have been involved this year in the committee meetings.
