## RECREATION DIRECTOR

Mr. Presot is not present due to the death of his brother-in-law. Mayor Procuk said that he and Councilman Selig met with Mrs. Lyndie Schuckert on Saturday afternoon to discuss some of the concerns she and Mrs. Tepley have regarding the recreation department activities including Art in the Park. Mrs. Schuckert said Mrs. Tepley would like to run a "Boot Camp Class" which is an extreme workout class. They would also like to form a co-ed volleyball group, reinstate Art in the Park (with more arts and crafts and less field trips) and paint some four square courts and hopscotch on the blacktop. They would like to have these items put in the Recreation Departments budget.

They also would like to purchase some equipment i.e.: tetherball and another game. This request was given to Park Board for consideration. Mayor Procuk said that Park Board has allocated \$1,000 in their budget for Art in the Park should it be reinstated.

Mr. Selig pointed out to Mrs. Schuckert that their age group needs to get involved in Home Days because that is where much of the funding for certain events comes from. Mrs. Schuckert told them it is difficult to be involved because she has two children. Mayor Procuk pointed out that her stepmother had no problem working Home Days with a blended family of six children. He said there are ways to work it out.

## POLICE CHIEF

Chief Algeri told council that he received the new contract from Bedford Heights for housing our prisoners and that the rate was lowered from \$85 a day to \$75 a day.

Mayor Procuk asked how that happened and Mr. Dowling said that he had spoken to the sheriff and asked for a lower rate.

Chief Algeri reiterated the Metro parks GPS program and congratulated Ptl. Zakrajsek as Parma Elks Police Officer of the Year for 2012. He said this is due to the excellent job he does all year and his part in the nationwide ticket scam last year.

Chief Algeri told council that Ptl. Ewelt arrested a party on Dorset for his 6<sup>th</sup> OVI and while he had him stopped he was made aware that Seven Hills had a warrant out on him for stalking. He is now spending eighteen months in jail.

Chief Algeri told council that he would need to put \$31,000 in his budget for the narrow-banding radios this year. The process will begin in March and they are trying to coordinate with all the communities to be changed at the same time.

Mr. Lahiff asked if this could be challenged and Chief Algeri told him that the FCC is not bending on this.

Mr. Foote asked if we will see any difference and Chief Algeri told him no. The only thing this does is it will allow the government to sell more radio space.

## **FIRE CHIEF**

Chief Lasky said he sent an email to all department heads regarding any items they want sold on eBay. Mr. Dowling will draw up the paper work, which will allow for eBay sales for the entire year.

Chief Lasky announced that the Promotional Test is set for April 11, 2012. Mayor Procuk explained the process. He said that the written test will be 50% of the score and then there will be individual assessments. The assessment committee would be an outside chief, a current department ranking officer (Capt. Calvillo) and a current member of the department not involved in the testing. Once the scores are compiled plus any other points (longevity, residency etc) the candidates will be listed according to their ranking. The Mayor, Chief Lasky and Council President Pro-tem will then conduct personal interviews with the top three.

Councilman Selig asked if there is a minimum passing score to receive any bonus points? The answer was 75%.

#### SERVICE DIRECTOR

Mr. Hatgas asked council for permission to do a 'full load test' on the generator that was purchased with funds from Homeland security. We cannot sell the generator so he is asking to have it attached to the Community Center to make the building a fully operational Emergency Center. The building is listed as a Red Cross Emergency Shelter. The cost to install the transfer station (which we already own with the generator) would be between \$10k and \$12k. He would like permission to go out for bids to do the work.

Mr. Lahiff asked if we could do this in collaboration with CERT? The answer from Chief Lasky was no.

Mr. Hatgas said that Terrace Construction is working at the creek on the sanitary pipe that runs from Seven Hills to Brooklyn Heights. The work will take about three weeks.

Mr. Hatgas reminded council that he would need \$12,800 in his budget for the narrow banding radios that are also mandatory for the Service Department.

## LAW DIRECTOR

Mr. Dowling reported that there would be a Housing Council (Community Reinvestment) meeting on March 12<sup>th</sup> at 4 pm.

Mayor Procuk told council that the Housing Council meeting could be an interesting meeting due to the fact that this will be the first time that Safeguard will be in violation of meeting the established threshold to continue the property tax abatement. This meeting will be chaired by the county and we will find out which school board member has been appointed to take Ron Kryznowek's place at the School Board Tax Abatement Member on this council.

Mr. Dowling said that our people have made contact with RITA but he has nothing to report at this time.

Mr. Black tentatively called a meeting of the Tax Board of Review Committee for 6:30 pm on Feb. 14<sup>th</sup>.

## **CLERK-TREASURER**

Mr. Clymer reported that the General Fund was down \$40,896 due to the first February RITA income from the last half of January being lower than the same time period last year.

Mr. Clymer told Council that the office is in need of a new copier. He had to go to Office Max on Friday to have copies made because the copier went down and the agenda had to be printed. He is seeking prices.

## MAYOR'S REPORT

Mayor Procuk has asked Fred DeFranco to give him a quote to handle our website. He said that the county also offers I.T. Services.

Mayor Procuk and several other area mayors attended a meeting on regional collaboration at Seven Hills. So far nothing has come out of the meeting.

Mayor Procuk said he did speak with Mayor Kurtz of Independence to see how they handle Animal Control and we may work with them on this.

Mayor Procuk attended the First Suburbs Consortium and he said the group is a model successful lobbying group for Economic Development.

Mayor Pocek from Bedford said they belong to the National League of Cities and for their dues of \$1500 to \$1700 he was able to get into a prescription drug program for his residents which saved the residents about \$27,000. Mayor Procuk will look into joining this group.

Mayor Procuk asked Councilman Lahiff if the Park Board talked about paying the expenses of reconstructing the Santa trailer. The cost of the materials was \$207.07. Mr. Lahiff said he would talk to WSC President Dianne Toronski and the Men's Service Club to see if this could be added to their budget.

Mayor Procuk asked Mr. Henry if he was going to look into a grant to repair the parking lot due to storm water run-off. Mr. Henry said he would work on procuring this grant.

Prior to continuing with Ordinances and Resolutions, Mayor Procuk explained to Mr.???? that due to the State of Ohio cutting local government funding, but encouraging regionalization and collaboration

amongst the communities, they are offering a grant, which would allow us to explore collaboration. By applying for this grant, the state would then ease the tax cuts at the local level.

Mr. Lahiff stated that the committee met and discussed going out for bid for rubbish contract for one-year and three-years. Also discussed a new truck, which was not well received and the streets program in the budget.
