Mrs. Guilfoyle congratulated Mrs. Hatgas on her appointment.

SNOW REMOVAL:

 To date we have fifty-nine at \$75 and five at the HEAP discount for a total collected of \$4,575

REMEMBRANCE CELEBRATION will be held on Dec. 4th at 5 pm.

The Website has been enhanced through the county and will load more quickly now.

The Social Worker (reinstated midway through the year) was used for 22.75 hours. 18.75 hours for the seniors and 4 hours were for other families.

RECREATION DIRECTOR

Mr. Presot stated that Basketball will begin this Saturday, Dec. 7th.

POLICE CHIEF

Chief Algeri said he missed the November council meeting due to his attendance at the Blue Coats meeting.

He said that the state-wide Drug Drop Box collection was 8,000 pounds of unused medications and that we participate in the county collection and from April thru October 2,285 pounds of prescription medication was collected in the boxes.

Our police and fire departments participated in the Greater Cleveland Safe Kids Mocktail Party and our theme was "walking dead". We won no prizes this year but Chief Algeri wished to thank Mike Tulcewicz, Chris Leahy, Dennis Derbin and his grandson, Tracy Harris and Chris Goldsworth who worked the booth and to the Procuk family and Councilman Lahiff who supported the event which raised over \$18,000.

Chief Algeri told Council that 'Shop with a Cop' is in progress. We can take one child for every \$150 in tickets that we sell. He said we will have 5-7 kids shopping at the Macedonia Wal-Mart. MOTION: Mrs. Presot moved to use the bus on Dec. 14th for 'Shop with a Cop'. Second by Mr. Black Motion passed 6-0

Mrs. Hatgas asked how the children are selected and Chief Algeri responded that Sgt. Ewelt worked with Mrs. Guilfoyle on the selection.

Mayor Procuk asked Chief Algeri to explain our jail. Chief Algeri said we are a 12-hour holding facility. We used to be a 12-day facility but the new restrictions and regulations prohibit us so we are contracted with Bedford Hts. at \$65 a day as our regional jail for anything longer than 12 hours.

Mayor Procuk asked about the rash of cars broken into along Schaaf Road. Chief Algeri said they were NOT broken into but the vehicles were left unlocked and easy targets. The thief

takes sunglasses, loose change, and rifles through the glove box and one GPS was stolen. His best advice is to keep your vehicle locked when unattended. To date, no one has been apprehended.

SERVCIE DIRECTOR

Mr. Hatgas congratulated his wife on her appointment.

Mr. Hatgas stated that the village sidewalk repairs are completed as is the Resource Dr. repairs.

The lights on the north side of the Municipal Building are working and the colors will change with the seasons.

The wiring for the generator is progressing and they will be testing the generator next week.

MOTION: Mr. Black moved to pay \$3,693.85 for front and rear springs on JUMBO. Second by Mr. Foote Motion passed 6-0

Mr. Hatgas said this truck is becoming a money pit. It is a 1999 vehicle and maybe council should look at retiring it next year.

Leaf pick-up will continue as the weather permits.

Mrs. Tesar asked that council identify their self when making a motion because a 'so moved' on the tape doesn't tell her who made the motion.

The Point of Sale inspections are slowing down but the rental inspections are brisk. There is a lot of interior remodeling going on within the village.

He is working with the fire department to get the businesses up to date with their Certificate of Occupancies.

ENGINEER

Mr. Henry said the concrete work on Resource is completed and construction is coming to an end for the season.

There will be some construction on Lancaster, work being done by AT&T to provide telephone service to a remote camera on I-480. This is for ODOT to monitor traffic patterns. This is not village related.

Mayor Procuk has received several calls regarding the enforcement of this ordinance.

Our Service Department works from 7:30 am to 3:30 pm and our 'trash to curbside' program for the Senior citizens has them putting the trash on the curb before 3:30 so others feels they can do the same.

Also to be in the Ordinance Committee will be an ordinance to recognize the Service Clubs.

After January 1st council will be reduced to five members with ten committees so please be prepared to chair two committees each.
