The Ordinance Committee meeting of the Council of the Village of Brooklyn Heights, Ohio was held on March 9, 2021 at 6:30 pm. with Councilwoman Presot presiding.

This meeting is called to discuss the Housing Council.

- Mayor Procuk explained that the Housing Council is to act as the Community Reinvestment Area Housing Council. This council is being re-enacted due to NIDEC. The council is made up of two (2) appointees by the Mayor, two (2) appointees by the village council and one (1) appointee by the village Planning Commission. These five (5) then appoint two (2) residents bringing the total to seven (7). This council meets once a year.

- Mr. Lahiff suggested they pick the two (2) names picked by the two (2) who have joined the call.
- Mr. Lasky does not want his two (2) picks to be eliminated because they were not on the call.
- Mrs. Safranek stated that no matter who they pick, the five appointed still have to appoint two (2) additional so they can pick from this list also.
- All of council agreed to appoint Mrs. Terry Safranek and Mr. Rocky Schuckert to the Housing Council and submitting the remaining names to the Planning Commission and then back to the Housing Council for consideration for the remaining appointees.
- Appointees were asked to email their information to Mr. Frank and he will pass it along to both Law Director Dowling and Val Snyder. There is a \$35 stipend for each meeting attended.
- Mr. Dowling will have the legislation ready for the next council meeting on March 16, 2021.
