WHEREAS, due to an accident on April 16, 2015, Signal Service did emergency temporary repairs to the street lighting at the Northeast corner of Tuxedo and Granger Roads were necessary.

- Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the Village of Brooklyn Heights. The reason for this emergency is so that the street lighting at the northeast corner of Tuxedo and Granger Roads could be repaired.
