CORRESPONDENCE

Mayor Procuk read a letter from Dianne Toronski expressing her thanks and gratitude for the nomination as the Elks Citizen of the Year.

Mayor Procuk reminded council that John Lambert's retirement luncheon is Friday, April 12th in council chambers and rsvp's are necessary.

Mayor Procuk responded to Christine Youngless from the Blue Wave Swim Team and let her know that council is considering making a donation of \$35 per resident for registration. As soon as she is done with her registration and gives us the information then it will be put before council for consideration.

There will be a public meeting tomorrow evening, April 3, 2013 at 7:00 pm at the Community Center. This meeting is the last of the legal requirements to try to obtain the \$200,000 Brownfield Grant for the property on E. Schaaf Road.

AUDIENCE

Mayor Procuk introduced 15th District State Representative Nick Celebreeze, of which we are a part. He briefed council on a few state changes including greater state cuts to the municipalities than the last cuts. The state is also considering the licensing of dog groomers in light of a dog's death while being groomed. Rep. Celebreeze has been appointed to many committees at the state level also.

POLICE CHIEF

Chief Algeri also reminded council about John Lambert's retirement luncheon on Friday, April 12th. The cost is \$8.00 per person and begins at noon in council chambers.

The Police department and animal warden attempted to catch a coyote in the Marko Lane area with no success.

We have received the application for the Bulletproof Vest Partnership grant. The process opens on April 8th and we will purchase five vests with the hopes of receiving a 50% reimbursement through the grant.

On April 22nd and 23rd Chief Algeri will attend the Command Level One Enforcement Conference on Handling Active Shooters and Mass Killing Situations put on by the Cleveland FBI at Richfield OPATA at no cost to the village.

COMMUNITY SERVICE DIRECTOR

Mrs. Guilfoyle stated that the lawn cutting program is moving along. At present, there are about twenty-five seniors signed up.

The Senior Luncheon will be on Friday, May 17th at noon and donations are welcome. Please have donations to her office by May 1st.

Mrs. Guilfoyle thanked council for reinstating the Social Worker. She is already working on one case and there is another pending.

The seniors have expressed an interest in attending the Cuyahoga Heights Middle School production of "Annie". The bus will take them to the 1:00 matinee.

The county is moving along on our website and we should see something very soon.

FIRE CHIEF

Chief Lasky reiterated the Prom Promise date and said that the participants include Valley View FD, Cuyahoga Heights FD, Parma FD and of course Brooklyn Heights fire and police.

He will be on a four day training with the county next week for the County Communications Manager class and from May 6th to May 10th training in Bowling Green.

County Executive Ed FitzGerald is putting a plan in place that would consolidate dispatching into four centers. The possibilities are Cleveland, Brecksville-Broadview Hts., Brookpark and the fourth is yet to be determined.

Mr. Cichocki asked how many people this would affect job-wise and Chief Lasky said probably 60-70% of the fifty current dispatch centers in the communities.

Chief Lasky attended a Meth Lab class at the Cuyahoga Heights Fire Department. It seems that meth labs are the up and coming thing in the neighborhoods.

Mr. Cichocki asked how this dispatch idea will impact our safety as a village.

Chief Algeri said that the plan ...911 Consolidation Plan ...is on the county website and cost has not been discussed with anyone yet. He said his concern is how do you take the eighteen cities in the Southwest Council of Governments, a population of 350,000 and 200 square miles and dispatch from one center and have good service.

Mr. Cichocki is concerned about the familiarity of the dispatching.

Chief Algeri said it will be a very high tech system.

Mr. Cichocki said that we are not all on the same radios and Chief Lasky said this is years down the road.

Mr. Cichocki said that right now, Mr. FitzGerald is pushing for a plan by August, 2014 but Chief Algeri said that if he heads to Columbus who knows what will happen with the plan.

Mayor Procuk said that we will not attend any meetings unless invited by Cuyahoga Heights to be present.

Mrs. Presot asked how the safety meetings with the school are going and Chief Algeri said there will be another meeting in June. She asked if there will be any changes come September and Chief Algeri said that they are currently working on the cameras and the plan is to have a couple of meetings every year.

Mrs. Presot asked if the teachers have had any training and Chief Algeri said that the teachers that have been there for some time had training through our SWAT team on lock-down drills and the bus drivers on bus assaults but the new teachers are trained on the safety policy.

Chief Algeri commended Mr. Piper for putting together a good safety plan and to Mr. Evans for keeping it moving forward.

RECREATION DIRECTOR

Mr. Presot said that soccer will begin this Saturday.

ENGINEER

Mr. Henry said he has had no response from the Rosby attorney regarding the leachate.

The State of Ohio will be advertising for bids for the Granger Road repairs.

The Park & Playground committee will meet on April 16th to discuss the broken fencing at diamond #2.

Mr. Henry said there is a resolution up for consideration tonight authorizing him to prepare plans and advertise for bids for the concrete repairs for Resource Drive.

Mr. Henry thanked council for their support of the OHIO EPA 319 program in the form of a resolution. This allows us with the West Creek Preservation Committee to seek financial assistance to design and install innovative storm water measures within the Brooklyn Hts. Park.

SERVICE DIRECTOR

Mr. Hatgas informed council that we received the Cuyahoga County Solid Waste District Recycling Grant and the magnets are on order.

We received the Cuyahoga County Sanitary Engineers report stating that \$79,446 was spent by them in Brooklyn Heights on: house calls, smoke & dye testing, cleaning of the sanitary sewers etc. This money comes out of the Sanitary Sewer Fund.

INDUSTRIAL DEVELOPMENT DIRECTOR

Mr. Perry, Mayor Procuk, Clerk/Treasurer Clymer, Mr. Dowling, reps from the Fed EPA and the State of OHIO met to discuss the Brownfield grant.
