Summary

In total, tax collections are still up over 2019 (2.4%).

Business withholding dropped in May, down 14.66%, but still up for the year, 6.4%.

Hopeful that business withholding will start to trend positive again and that we will see the negative variance in individual receipts turn positive once individual income tax returns are filed with the July 15th deadline fast approaching.
