Each of the new officers thanked council and gave a short description of their previous employments and introduced their family members.

#### POLICE CHIEF

 Chief Meade read a letter of resignation from Ptl. Gary Foote. Gary served seven (7) years on the BH Fire Department and thirty-one plus (31+) years on the BH Police Department. His last day will by August 13, 2021. Chief Meade responded in a letter to Gary that he will ask council that Gary's healthcare be paid through the end of August and that he be allowed to purchase his service revolver for \$1.00.

MOTION: Mr. Lahiff moved to carry Ptl. Gary Foote's healthcare to August 31, 2021 and that he be allowed to purchase his service revolver for \$1.00. Seconded by Mrs. Presot Motion carried 5-0

Mayor Procuk mentioned that a bear has been confirmed in our area (NOT SITED) by animal
control and the Ohio Department of Natural Resources and asked that residents take steps to not
attract it.

#### SERVICE DIRECTOR

 The lights on diamond 2 will be replaced per our ten-year agreement with MUSCO Lighting. We plan to continue the ten-year agreement depending on the cost.

# **COMMUNITY SERVICES**

- Next Senior Social will be August 24<sup>th</sup>.
- Art in the Park program concluded on Friday, July 30<sup>th</sup>. There were fifty-three (53) kids and thirty (30) volunteers involved. The high school volunteers racked up about 735 community service hours.
- We have submitted for the 2022 grant for Art in the Park asking for \$5,000 again and we should know in September if we receive it.
- The NOACCA grant deadline is this Friday, August 7<sup>th</sup> and we should know in November if we will receive it.
- The Back-to-School program began and we are helping seven (7) families with back packs and school supplies.

#### **RECREATION DIRECTOR**

The summer sports season has concluded and our Boy's Majors team won the championship.
 The team was coached by Rocky Schuckert, Jason Sciano and Shane Tommer.

#### **BUILDING DEPARTMENT**

- Several Point of Sale Inspections
- Rental property registrations and inspections
- 600 W. Resource has made some minor modifications
- Old J.V. Janitorial building (now a repair shop) has been greatly improved.
- We have a property in the village, licensed by the State, growing hemp, cannabis and marijuana.
   They have signs out advertising this also. Mayor Procuk said we would take a look at the ordinances on the moratorium and if they have expired he will call for an Ordinance Committee meeting.

### **ENGINEER**

- In contact with our insurance company regarding the Tuxedo roadway repair where the water main broke. The forensics evaluation should be completed by the end of this week.
- The Service Department has done a great job containing the gravel.
- Mr. Henry is concerned that if we do anything they wouldn't back it and would not pay out anything.
- He anticipates getting the report from the insurance company this week and is hoping that by the
  Streets meeting on August 17<sup>th</sup> there is some movement to have the area repaired. Not only do
  we need to repair the hole from the break, but the pavement buckled closer to the Community
  Center drive and that repair will be costly. Cleveland will not pay for that area that is damaged.
- By the middle of August we will have the Master Plan and report to council in September.

## **MAYOR'S REPORT**

- Mayor Procuk obtained a copy of the Valley View ordinance from 1999 regarding their park which
  says "only residents and their guests may use the park". He said that when council begins
  discussing the park, he know this will come up so he will put a copy in their mail and the
  Ordinance Committee can begin the discussion.
- Because of the turmoil with getting the healthcare contract signed, Medical Mutual gave us July 1<sup>st</sup> as the effective date and will resubmit the claims from the changeover because the benefits package has some vast differences to what it was prior. Due to the Memorandum of Understanding of a \$250 deductible with the Police Union we had to pay a two of the police officers the \$250 in excess according to the terms of the contract. Mayor Procuk said he did not do anything with the other village employees, because while in essence the police officers are due the \$250 in excess the others still have to pay the \$500 deductible for the year.
- While the employees were given explicit instructions on the healthcare, we will have Ted Biskind come out and meet with them to explain the plan.
- Mayor Procuk attended the Board of Health meeting on July 28<sup>th</sup> and was recognized to speak
  even though he was not on the agenda. He gave them the latest colorized aerials. He has many
  people helping him with his presentation.
- The public Board of Health meeting will be on August 11<sup>th</sup> and residents will be allowed to speak for three (3) minutes each.
- Thanked Councilwoman Presot, Councilman Blados and Councilman Walsh for their help in promoting the meeting.
- There will be busses for those who choose to use them.

#### **LAW DIRECTOR**

- Need to amend a few typos in the charter amendments.
- Sheila will attend the next meeting as Mr. Dowling will be on vacation.

#### **COMMITTEE REPORTS**

Parks, Playground and Community Services Committee held a short public hearing to present an application for the Community Services Department for a grant to apply for a new large bus for the village.

Mr. Lasky asked for additional information regarding Honeywell cancelling the maintenance agreement and Mayor Procuk explained that several years ago, when the upgrade was on council floor that the maintenance was included. Honeywell feels that we owed them around \$17,000 for the maintenance agreement. There was threatened litigation on both sides and he felt that it was better to spend a few hundred dollars on service calls than to pay them \$17,000 because we firmly believed that it was the agreement even though they felt differently. We are potentially walking away with substantial savings. Mayor Procuk said that the agreement was about to run its course in about six months. Basically, if we need them to come out to check the efficiency on something we will pay a service call instead of a maintenance agreement for the final two years which they backdated to 2019 so it will expire in the next few months.

Mr. Lasky also asked where the funding for the lighting will come from. Mayor Procuk said that when the school gave us the lights we also contracted with MUSCO and part of the purchase agreement included the replacement of all lamps every ten years. When the first agreement expired council choose to purchase another warranty or agreement for a complete replacement, thus we will not be paying for the bulb replacement because it is under the current agreement.
