## FIRE DEPARTMENT

- MOTION: Mr. Lahiff moved to pay National Tire \$2,670.24 for six (6) tires for E-47.

- Both the engine and the ladder passed their pump and ladder testing this year. We had an issue with E-47. It is twenty-five (25) years old. We have applied for a grant for a new vehicle and we are waiting to hear about that.   - 1. MOTION: Mr. Lasky moved to pay Sirna Construction 1,512 for road repair at 4920 Van Epps Road for a new hydrant installation. To be reimbursed by the City of Cleveland, Division of Water. Seconded by Mrs. Presot Motion carried 5-0
  - 2. MOTION: Mrs. Presot moved to pay LISCO Heating and Air Conditioning \$1.144 for a new EMC blower motor for the air conditioning in the gun range. Seconded by Mr. Lahiff Motion carried 5-0
- Closed the month of July with \$2,063,000 in the General Fund. Operating at 6% under budget.
- R.I.T.A. drop for August was \$1.075.697. This is a one-time influx.

    - Spring Road in excess of \$1.7 million

    - Dorset Area in excess of \$1.6 million Numbered streets 6<sup>th</sup>, 7<sup>th</sup> & 8<sup>th</sup> at \$100,000 each
- Mr. Lasky would like to see some of the General Fund surplus moved to the Capital Fund for infrastructure and the Fire Department

# **SAFETY COMMITTEE**

  - Discussed the staffing difficulty within the 5 mile radius for new hires.
  - Looking at changing the radius to 15 miles for new hires only.
  - With several retirements within the department they are looking at doing some additional hiring.
