POLICE

- Chief Meade gave council the figures /financing for three new cruisers and told them the pricing is locked in until Feb. 18th which is two days after the Finance meeting.
 - o Mr. Lahiff said this needs an ordinance and the information is good for discussion but council is not ready to make a decision at this time.
 - o Mr. Walsh said there is no hurry to make a decision tonight and Mr. Lahiff said they couldn't because it needs legislation.
 - o Chief Meade said he gave them the information so they could begin the legislation
 - Mr. Lasky said the need to look at all Capital needs: our infrastructure, our roads, Service Dept. vehicles, Police and Fire and decide after they get a game plan for the entire package.
 - o Chief Meade mentioned again that the rates will change after the 18th.
 - o Mr. Walsh said they will meet on the 16th to discuss the entire package and Mr. Lahiff said they could make a decision that night and then he would have until the 18th to still get the prices.
 - o Mr. Frank asked Mr. Dowling if they could call a special council meeting on the 17th and what the advance notice time is. Mr. Dowling said they have to give 24-hours' notice.
 - Mr. Walsh said they would meet on the 16th to prioritize the needs and he doesn't see what difference a few days would make if they want the sale.
