- Notices went out regarding a Public Hearing on Dec. 18th at 6:30 to discuss the Ordinance to rezone the Geis Property.
- We received a check from the insurance company for damage to the guard rail at I-480 and Granger Road in the amount of \$4,849. The contractor cannot accept the insurance check so we have to deposit it and pay the invoice. MOTION: Mrs. Presot moves to pay Lake Erie Construction Company \$4,849 for repairs to 200' of guardrail at I480 & Granger Road. Second by Mr. Lasky Motion carried 4-0

FINANCE COMMITTEE

 Mr. Lasky reported that the Finance Committee met with the department heads of the Community Service Department, Service Department, Police Department, Recreation Department and the Engineer. Will set up a meeting with the Fire Department and the goal is to submit the budge to the county in early 2019.

CLERK/TREASURER

- Thanks to everyone for helping make this a smooth transition
- After January 1st 2019, he'll have actual numbers for all funds.
- Should start 2019 with \$500,000
- Mr. Walsh played devil's advocate "where is the income tax increase going"?
- Mr. Frank said it is a slow process and we have put \$235,000 towards capital improvements and two new police officers.
- We have a budget of \$8,500 for 2018 and \$8,500 for 2019 to update the codified ordinances. The cost will be about \$10,100 to update and \$700 for the on-line updates. We will have about \$4,000 to decide what we do with it.
- Mayor Procuk suggested we contract to pay some in 2018 and the rest in 2019. We would need
 an ordinance for this.
