Mr. Hatgas left the meeting.

CLERK / TREASURER

- Mr. Frank asked to discuss the financing for the new ambulance. Council agreed on a seven (7) year financing agreement with KeyBank. The payments will be \$45,000 per year. Mr. Frank will get the paperwork together and submit it to KeyBank.
- Per our agreement with Medical Mutual, our twenty-fourth (24th) payment is waived so the employees will not be paying their thirteen percent (13%) in June.
- Val Snyder (payroll administrator) and Dana Bundus (accounts payable) are cross-training.
- The vehicle e-checks are complete and will be submitted to the State of Ohio for license plate renewals.
- The Service Department's new truck financing is complete.
- We ended April in a deficit but we did have three (3) pays.
- We are operating at 3% under budget
- R.I.T.A. income for May is \$777,000.
- Mr. Frank is researching the American Rescue Plan Act funding. It looks like we will receive some funds and that they would have to be spent by 2024.

Councilman Lasky said that if we have the new service department pick-up truck with the plow and dump bed now are we putting the old dump truck on gov.deals to try to recoup some money. Mayor Procuk asked who he is asking the question of since Mr. Hatgas left the meeting a while ago.

MAYOR'S REPORT

- Mayor Procuk asked council how they feel about closing Schaaf Rd. on September 11th for a K race sponsored by the VFW on Schaaf Road. All council members agree that we can do that.
- Charter Review Commission has met twice and elected Les Foote as chairman and Traci Ellacott as secretary and they are proceeding with their due diligence.
- Our tax administrator is recommending that council discuss another subpoena and filing letter program that R.I.T.A. offers again this year. In 2019 we had \$31,000 in outstanding taxes and collected \$17,000. The cost to the village was \$1,648. In 2020 we had \$7,000 in liability and collected about \$3,900. Mayor Procuk told him to move forward with the program.
- Mayor Procuk is working with the county to collect property tax that is owed to the village.
- There will be no Memorial Day Parade but he is contemplating having the VFW do a short service
 at the Community Center. He will have the flags out a week prior so that residents can safely
 place a flag at the monument.
