MOTION: Mr. Foote moved to approve the minutes of the Special Meeting of March 18, 2014 and Regular Meeting of May 6, 2014. Second by Mr. Selig. Minutes approved as distributed 5-0

CORRESPONDENCE

Mayor Procuk received an e-mail from Cub Scout Leader Ray Berzins requesting the use of Pavilion 1 for a scout meeting with the fee waived.

MOTION: Mr. Black moved to waive the fee for Pavilion #1 on June 7th for a meeting of Cub Scout Pack 28. Second by Mr. Walsh Motion passed 5-0

Mayor Procuk read an e-mail from Anne Graham regarding the BHV Social Club and the waiving of the rental fee for the pavilion for a club picnic. See attached

Mayor Procuk reminded council that they did in fact vote to allow the club four days (one per quarter) with the rental fees being waived. Since she has already paid the fee to reserve a pavilion for two days in July a motion was made to refund the payment.

MOTION: Mr. Selig moved to refund the fee paid for the pavilion to the BHV Social Club. Second by Mr. Black. Motion passed 5-0

Note: Mr. Black asked that Ms. Graham be made aware that council passed the original motion several months ago allowing them the use of our facilities without charge once per quarter.

Mayor Procuk read a thank you note from Dolores Brzuziewski for their senior outing.

A thank you note from Weltman, Weinberg & Reis for waiving the pavilion fee for their I Team Building picnic on August 22nd.

Mayor Procuk read a copy of the letter Valley View Mayor Piasecki sent to the school board thanking them for reconsidering the pre-school bus for the coming school year.

Mayor Procuk said that the Silver & Gold College Scholarship applications are still being accepted. This is a scholarship for the children of Safety personnel. The deadline is June 14, 2014.

Mr. Dowling said that the attorney for the Board of Health forwarded the Rosby information to the county prosecutor.

AUDIENCE

Ruth Mocadlo of 5054 W. 6th Street said she had some concerns regarding the crime in the area lately.

- 1. She said that their car was broken into on Sunday night and that her husband was running late on Monday morning so he went to work and did not call the police until returning home that afternoon. She said the officer took some pictures but said that they could not lift fingerprints because he did not call right away.
- 2. She said she witnessed a high speed dirt bike chase in our park and that her 13 year old son has told her about drug activity in the woods and on the walking trail.
- 3. She is concerned with the vandalism in the park
- 4. She is concerned about the businesses and asked if we have a business liaison to keep business in the village.
- 5. She is concerned with the speeding on North Street. Would like to see us prevent something from happening. Suggested a stop sign on North to slow people down. She feels it is an easy cut through because of the stop signs on Tuxedo.
- 6. She asked if we have cameras in the park to which the mayor replied that Chief Algeri would have to answer that because that would be a surveillance question.

Mayor Procuk told Mrs. Mocadlo that we are a small village, 1.7 square miles, and that we have a minimum of two officers on duty 24/7. He did say that number is high because of the per capita number. He also said that the stop sign placement is regulated by law but he has always been perplexed because we have a stop sign at three of the four numbered streets on Tuxedo.

Chief Algeri addressed some of her concerns. He said that we do have cameras in the park and we have recorded pictures of some of the kids but unfortunately we can't identify them and the cameras can only do so much but they are looking at adding a couple of cameras to the more problem areas.

Chief Algeri said they would set up the speed box on North to try to slow down the traffic.

Chief Algeri said that Parma had 20 vehicles broken into. We had 5 cars at 3 houses broken into and 1 car stolen. Her car was the first that had damage. Most are unlocked. He said that the stolen car had the push button start and a key fob is needed to start the car. The fob was in the cup holder so the kid started the car and off he went. The car was recovered a few days later on I-176 with no damage.

Chief Algeri said it is best if you keep your vehicle locked and don't have any valuables in sight.

Chief Algeri said they would do their best to address her concerns and Mayor Procuk said that there are never less than two officers and three Paramedics on duty at all times. He said that all of our departments work hand in hand to keep our village safe and he thanked Mrs. Mocadlo for coming and voicing her concerns.

Mr. Ted Biskind is in the audience tonight to explain some changes to the employee health insurance. He explained to council that the early renewal done last October, which would have been effective from 12/1/13 to 12/1/14, did not happen so as of July 1 2014 we must renew again. In October we agreed to a 5% increase but now that increase would be an additional 8.4% totaling 13.4%. Mr. Biskind recommends that we renew the plan now and we would be locked in until 2016.

Mr. Dowling said that he was asked to look at this issue and he got a proposal from another company willing to compare apples to apples and it looks like they can save us a substantial amount of money.

Mayor Procuk asked if we would have to complete the questionnaire again and Mr. Biskind said that there are no medical questions asked. The only question is to identify the smoker and non-smoker in each family. There is an additional surcharge to a smoker.

Mr. Walsh called a Wage and Salary Committee meeting on June 17th at 5:00 pm to discuss the employee health plan with Mr. Biskind and the firm Mr. Dowling spoke with.

Mayor Procuk asked to take a few ordinances out of order at this time.

COMMUNITY SERVICES

Mayor Procuk said that Mrs. Guilfoyle's mother was taken to the hospital this afternoon so he will give her report.

- Mrs. Guilfoyle will have the Senior Olympians present at the next meeting. She wants to be in attendance
 with them. They are: Walter Allen, Dolores Brzuziewski, Ray Mehalko, Kathy Mehalko, Lorraine Safran and
 John Spilka.
- The Senior Recognition Luncheon was a success. There were sixty-one in attendance and thirteen meals
 delivered. Thank you to Mayor Mike, John Black, Chief Algeri and Ed Hatgas for their help serving and to all
 who donated door prizes.
- The gray Crown Vic has brake issues and needs new tires. Mrs. Guilfoyle is hesitant about putting money
 into this vehicle if there is any chance that they may get a replacement vehicle (from our current fleet). She
 asked if any decisions have been made yet. She is looking at the mayor's vehicle (with 122k miles) as the
 replacement.
- Martha Hagan has been hired as a driver and is an asset to the department.
- Art-in-the-Park has thirty-seven kids signed up. Mrs. Guilfoyle met with Jessica and Mindy to set up the
 program. Speakers are in place and the volunteers have been back-ground checked thanks to Det. Mike
 Tulcewicz and there are several community service students in place. Mrs. Guilfoyle is requesting \$200
 from council for the program because Park Board only gave \$300 this year due to the low number of
 children last year and the expenses being \$250.
- Safety Town is ready to go with transportation.
- Mayor Mike Senior Chore program will be on July 24th. Thanks to Matt Walsh for laying the groundwork.
 Senior sign-up will begin when the June Breeze is delivered. Last year we had ten households sign up.
- The Star-Spangled Spectacular will be on Public Square on Wednesday, July 2nd. The village bus will take people down at 6 pm. The concert begins at 9 pm and then they will be transported back.

RECREATION DIRECTOR

- Games began last Wednesday. There are 144 kids on 22 teams for baseball/softball
- The Adult Co-Ed Softball League will not happen this year. There were only three teams committed.
- Sign-up for the Men's and Women's leagues will be in the next Breeze and also on the website.
- The Fall Soccer sign-up is on the website. We had two Spring soccer championship teams.

INDUSTRIAL DEVELOPMENT

- Schaaf Road property: Mr. Perry said that we received an extension through November 30th to mediate the land. Chagrin Valley Engineering will survey the area and we will get a "no further action" letter from Solar Testing.
- OMNI: Mayor Procuk, Sheldon Socoloff and Ken Perry met with the people from OMNI and again told them
 they have to meet with the Zoning Board of Appeals to move forward with their project. He has reached out
 to the mayor's gal Kari and to date they have not contacted anybody.
- Mayor Procuk and Mr. Perry will meet with Health Span next month just to keep in touch.
- Mr. Perry thanked our police department for calling him when they saw some moving trucks at Weltman, Weinberg and Reis. It turned out they were just moving some office equipment around.

SERVICE DIRECTOR

- Council was given a 'house breakdown' (the number of residential homes) for each area of the village.
- There is an ordinance up tonight to sandblast the L7501 Sterling snowplow truck. By doing this we will get another five years of use.
- Holiday garbage pick-up was extremely heavy on Saturday. They (Kimble) had to dump twice and did not finish collecting until about 6pm. The recycling truck damaged a tree lawn tree at 5074 W. 5th St. Chief Algeri and Mr. Hatgas will work with Kimble to get this taken care of.
- The Cuyahoga County Board of Health went to Marko Lane to check out a report of mosquitos. The
 mosquitos are in the woods and they don't treat the woods. They will treat standing water and the catch
 basins. The residents took care of the woods themselves.
- Mr. Walsh asked about putting a Porta-pot at the Dorset Dr. mini park. Mr. Hatgas said there hasn't been
 one there in four years and the cost is \$75 per month. Mayor Procuk said to put one there for the remainder
 of the summer and we'll readdress it next year. Chief Lasky said that some of the baseball teams practice
 there.

 Mr. Walsh thanked Mr. Hatgas for taking the time to discuss the lateness of the garbage pick-up on Saturday.

FIRE CHIEF

- The department has applied for a BWC Safety Grant for new cots for the ambulances. The grant is for \$40,000 and the village would be responsible for approximately \$12,000. The cots are \$35,000 each but thanks to Asst. Chief Stefanko we will get a lower price so we can purchase two. Chief Lasky thanked "his gal" Donna Tesar and Asst. Chief Stefanko for the work they put into this application including an assessment of the Fire Station.
- Hydrant flushing has begun and will continue until June 14th.
- Accidents on I-480 have increased, probably due to the I-77 construction.

POLICE CHIEF

- Safety Town will be June 16th through the 27th. Officer Tulcewicz will again be in charge. This is his 17th year.
- The Independence police notified us that they will close their portion of Schaaf Road on June 21st from 8 am
 to 1 pm for a charity event for Strong Style. We will inform our residents that they will not be able to go
 down the hill during that time.
- Chief Algeri has been taking applications for Park Specials and Jailers. We have four applicants for Park Special and one for jailer. He would like to hire one Park Special and that would bring the force to four.
- Chief Algeri would like to begin to test for full-time patrol officers to replace Officer Papp and to have an eligibility list. All of Officer Papp's shifts have been filled by part-timers.
- Chief Algeri would like an Ordinance committee meeting to discuss amending the requirements.
- Officer Tulcewicz was working off duty and spotted a red pick-up truck in a parking lot. Since we had a few incidents involving a red pick-up truck he called the duty officers. They responded and it turned out to be the notorious Willie Farley, whom Det. Bru sent to prison a few years ago. They told him to stay out of Brooklyn Heights. Fast forward to 5 am this morning and Officer Foote spotted a red pick-up truck on Granger Road with a load of scrap that appeared to be from the General Awning dumpster. As it turns out it was Willie Farley and he was arrested and will appear in court next week.

Mr. Foote asked the chief to speak with Independence about the loose gravel at the bottom of Schaaf Road hill (Independence Excavating). He said it is very dangerous there.

ENGINEER:

- Mr. Henry spoke of the ordinances that council will vote on tonight regarding the Lancaster Rd project and the survey of the village owned land on Schaaf Road.
- Once the contractor is approved for the Lancaster Rd. project, they will set up some minor asphalt and concrete repairs on Dorset using the same contractor.
- Mr. Henry addressed the storm of May 15th and said that West Creek did not suffer any major problems but that NEORSD has it on their radar watching for erosion.
- The construction on Lancaster will begin after July 4th and will take about twenty-five (25) days.

Mr. Walsh asked if anything will be done for the McGillivray's. Mayor Procuk said this has been discussed several times over the last 10 years. Mayor Procuk said that will be put in Streets Committee for discussion. He said that he, Mr. Henry, Mark Link from NEORSD, the law director and anyone else who would like to attend will go to the site again.

BUILDING INSPECTOR

- The total value of permits issued to date is \$840,470.
- Point of Sale inspections are extremely active due to the low interest rates.
- Regarding the Seven Hills generator, they took the readings but couldn't find the paperwork. He will look for
 it and get it to Mr. Socoloff when he finds it.
- The progress at 196 Marko Lane is slow, however, 193 Marko Lane is moving along quickly.
- The drawings for Calvary Chapel have been conditionally approved and Pastor Dennis has been informed that they can begin the permit applications at any time.
- 925 Keynote Circle (OMNI) has been offered as much assistance as we can give. They are not moving on it

- Mr. Clymer gave council a detailed report on the RITA income to date. He has asked the Tax Administrator to work with him to find out why the variances in the RITA collections.
- The audit came in with a clean opinion.
- He will work on a mid-year finance review with Mrs. Hatgas and then distribute it to council.
- There is an ordinance to amend the appropriations up for consideration tonight.
 - 1. To adjust the Revenue Sharing for the School District due to the RITA collections
 - 2. To increase the Law Enforcement Trust Fund to appropriate for the additional TASERS.
- Mr. Clymer will be on vacation from June 26th to July 3rd so he will miss the July council meeting.

Mr. Black offered thanks to the administration and Mr. Clymer for the work they do to get the clean opinion on the audit. Mr. Clymer then thanked his "gals".

We are hosting a family picnic, which will be preceded by a neighborhood walking tour in which participants answer clues and stops for activities. Due to the heavy weather dependency to accomplish this activity, we booked the second date only as a rain date (and will not use the pavilion if the first date works out).

I already paid a \$150 deposit for both dates, but wanted to see if Council is willing to re-consider waiving the fee for the pavilion deposits so that we can shift our personal donations to focus on hosting the community event and offering prizes.

Note we do plan to charge a nominal fee of ~\$5 per team for the activity (no fee will be charged for people interested in attending the picnic only). We desperately need to raise funds to continue to host future events. Much of that funding will likely be targeted to prizes and food contributions to the picnic, with any remaining funds to be seed money for upcoming events.

To aid your consideration let me point out a few facts:

- Our BHV Social Club membership is at 59 people with only 7 being non-residents. (See membership list attached.)
- Our club has hosted 10 events to date since it started in Oct 2013, only one event (the Children's New Years Eve Party) has used a Brooklyn Heights facility.
- All three of our 2014 events to date have taken place outside the Village because we used free facilities that were offered by Mayor Bacci of Cuyahoga Heights and Principal Evans of CHS schools.

We are looking forward to seeing if Council is willing to reconsider supporting what is now the largest club of residents in the Village. Our desire to build a stronger community has led to our planning team of five young professionals to spend many hours of our personal time and hundreds of dollars out of pocket supporting our club events. We hope you now realize that asking us to have a non-profit status on top of these support requirements is not realistic. Hence we may not ever meet the criteria you passed in your Resolution last December but that won't stop us from existing (as much as some folks are hoping it will).

Our focus has not changed since we started - to continue to build our membership. The rewards of connecting with our residents far out ways any challenges put in our path either by Council or the 2014 Home Days Committee who refuses to give us a community booth because "we don't provide any value to the community." That type of narrow-mindedness is exactly what is driving residents to join our club and drive change within the Village.


