- Officer Angelone has been called to duty by the Air Force Reserve from early April to the end of November and for training for a couple weeks in March.
- NOPEC notified that customers will be receive the first installment from the settlement negotiated by the OCC and NOPEC.
- Rocky Schuckert, President of Men's Service Club, is requesting an improvement to the baseball fields by adding covering for the dugout areas.

<u>MOTION</u>: Mr. Walsh asked for a motion on behalf of Interim Service Director Florjancic to pay Pioneer Athletics \$3,469.91 for the sports field paint. Seconded by Mrs. Presot, Motion passes 5-0.

CLERK / TREASURER

- The 2020-2021 audit is in progress.
- He is working with the County on a very small parcel of land that the village purchased as part
 of the deal with West Creek for preservation purposes. We received a tax bill on this parcel
 but are working to file a tax exemption.

MINUTES OF A MEETING

- An update on the RITA subpoena program was received and will continually be updated. To date, the liabilities established \$21,082 in the amount collected to date \$7,260, our cost is \$205.
- The RITA drop today was \$155,000 gross minus \$4,600 equals \$151,000. We have received \$770,526 to date, \$77,000 of that will go into the Capital Fund.
- The General Fund is just over \$2,057,000 which is almost an \$116,000 surplus; the Capital fund is at \$1.1 million and Economic Development is at \$595,000.

MAYOR'S REPORT

- The Park Board met and a resident asked about the materials that will be used under the new playground equipment. That question was referred to the Engineer.
- It appears that more money will be allotted by Governor DeWine funding police body cameras and that we are confident that we will be awarded grant dollars for this.
- No one can offer clear information on municipal tax refund on remote workers and we will have to wait and see what happens.
- As mentioned earlier, Police Officer Angelone has been called to duty by the Air Force Reserve and we'll basically lose him from April through November.
- Soccer sign up will be by paper sign up this season due to the untimely acquisition of SI Play by Sports Engine.
- The second RITA drop in February was \$156,000 which gave us \$770,000 in municipal income tax for the month.
- We anticipated collecting about \$1.1 million and we've actually collected about \$1.441 million putting us up by \$350,000 in collections.
- We've added \$144,000 to our Capital Fund thanks to going to the 10% transfer plan.

Mayor Procuk asked to go into Executive Session to discuss the Cuyahoga County Board of Health and the Deny the Permit process.

FINANCE COMMITTEE

 Mr. Walsh reported that at the Finance Committee meeting this evening the budget was reviewed with Department Heads. We will have a meeting to discuss the Capital Budget on March 1st at 6:45 pm.

- Mr. Blados reported on the February 8th meeting regarding the upcoming road projects and repairs, the asphalt program, the Galway & Lancaster timelines.
- Engineer Henry reviewed the related ordinances that will be voted on later tonight.
- Mr. Blados scheduled a Park, Playground meeting to discuss dugout cover and fencing for Tuesday, February 22nd at 5:00 pm.
