### FIRE DEPARTMENT

- Asst. Chief Lasky told council that they are in the process of getting quotes to do the kitchen floor.
- Capt. Pat Cannon will be moving out of the village around August 2021. He has been on the department for 26 years.
- Another member will also be moving out of the area (no name given) so they want to hire two (2) firefighter/EMS members in the near future.
- They will have a meeting regarding the ambulance so they will have some firm numbers soon.
- Mr. Lahiff asked about the water leaking into the basement and Asst. Chief Lasky said that Mr. Hatgas is aware of the problem and is getting quotes for repairs.

## LAW DIRECTOR

- Mr. Dowling said they will move forward with the Job Creation Incentive Grant Agreement.
- There was no audience at the Public Hearing tonight so they will move forward with the Agricultural District 5 Year Renewal for 24 E. Schaaf Lane and 4933 Schaaf Road ordinances tonight.

#### Clerk / Treasurer

- Mr. Frank asked for a motion to pay \$245 to Bricker and \$2,000 for the work done to get the
  designations of the CRA and the housing. Mr. Lasky moved to pay these bills. Seconded by
  Mr. Lahiff Motion carried 5-0
- Mayor Procuk asked if we collected the \$10,000 from NIDEC for those expenses and Mr. Frank said we did.
- MOTION: Mr. Lahiff moved to pay Charles E. Harris \$1,300 for the preparation of the 2020 Financial Statement. Second by Mrs. Presot Motion carried 5-0
- MOTION: Mr. Lahiff moved to renew the contract with Charles E. Harris for three years expiring in 2023. The cost of which will increase by \$50 per year. Seconded by Mr. Walsh Motion carried 5-0

### **MAYOR'S REPORT**

- The Planning Commission met by ZOOM last night and selected Michael Calvey for the Housing Council. The five members will meet and select the two (2) additional members. They will then meet and review NIDEC's final numbers and make their report to the county by March 31, 2021.
- John Triner attended a Cybervision seminar for us. We are in great shape with the fire walls and security he has installed for us. One aspect of the seminar was to make sure that we have proper insurance coverage in case ...... and Mr. Frank checked with our insurance company and found that we have had a policy in place for several years.
- We are operating at 2 1/4% under budget at this time.

## **WAGE & SALARY COMMITTEE**

Mr. Blados reported that the committee met tonight to discuss the employee health care. Mr.
Frank will reach out to the three agents they selected for proposals. He also said that they would
like to include representation for the employees. He will let everyone know when the next
meeting will be.

## PARKS, PLAYGROUND & COMMUNITY SERVICES COMMITTEE

 Mrs. Presot said the committee met tonight to discuss increasing the sports fees for nonresidents. There will be separate fees for players in our school district versus those outside our district.

## **STREETS COMMITTEE**

- Engineer Mike Henry gave a three five year plan.
  - > \$50,000 to replace guardrail on Granger Road
  - > Pavement repair on the numbered streets
  - > Repair the Fire Department apron
  - > We have grant money for Spring Road repairs
  - ➤ In 2022 complete repairs of Dorset, Galway, Bancroft & Dunedeen at a cost of approximately \$2 million.
  - > 2023-2024 make repairs to Valley Belt Road at a cost of approximately \$800,000.
- Mayor Procuk said that if the \$293,000 gets filtered through the State of Ohio for further COVID
  relief, we're going to look very hard at using that toward wages for the safety forces by he would
  ask, if it comes true, that council would consider then moving the \$293,000 towards street repairs
  so we would be ready to pay the bills when the work is completed in a couple of years.
- Mr. Laky said that Mr. Henry would like another Streets Committee meeting held later in the year to get things moving and contractors ready so that in 2022 we are ready to rock "n" roll.
