DEPARTMENTS

FIRE DEPARTMENT

- MOTION: Mr. Walsh moves to renew our fire hydrant contract with the City of Cleveland in the amount of \$4,341.06 for the rental of 179 hydrants. Seconded by Mr. Blados. Motion carried 5-0.
- Had a significant hazmat run this week due to a chemical spill. SERT Hazmat team and other mutual aid on the scene. There were a couple of injuries.
- Sadly report that Steve Peine passed away. He was the CERT Executive Director for several years. A moment of silence was observed.

CLERK / TREASURER

- All information was submitted to update our ordinances and charter. I will share the cost once I
 receive the quote.
- Working with law, the county and auditors to create Fund 920 Unclaimed Funds to clean up miscellaneous funds.
- One of the ordinances tonight is the re-appropriation of the fiscal year 2021.
- Final RITA Drop for December, 2021 was \$475,943. \$47,000 will be transferred to the capital fund. Ending the year with \$7,149,728.61 in municipal income which is about 10% over our prediction.
- In early January I will be working to get the budget process started.

LAW DIRECTOR

 As of January 1, 2021 there is a vacant seat on council. Council has 30 days to appoint a new council member. Deadline is end of business on January 31st.

MAYOR'S REPORT

- Financial report is spectacular. The prediction was to raise \$6,500,000 this year and we raised \$7,149,728 which is \$650,000 (about 10%) more than anticipated.
- In 2020, the first full year of Covid, we brought in \$6,355,000 which was \$795,000 (about 12%) more than we anticipated. In 2019 it was \$5.9 million. We're collecting 21% more than we collected in 2019; about a 54% increase from 2018; and about a 56% increase from 2017.
- This is due to significant Economic Development growth.
- The village is up \$2.5 million that just a short time ago and the future is very, very promising due to businesses that have come in in the last 12-18 months.
- With money going into the capital fund, we can start road projects; we've reinforced our vehicle situation in three departments; and we've brought the police department back up to 17 full time officers.
- In January council will be asked to select a president pro-tem
