1426.01 CODE ADOPTED.

There is hereby adopted as the Electrical Code of the Village the most recent edition of the National Electrical Code, and any amendments made thereto, prepared and promulgated by the National Fire Protection Association, and designated NFPA 70, and the Ohio Board of Building Standards.

1426.02 PURPOSE.

The purpose of the National Electrical Code, as adopted in Section 1426.01, is to provide specifications for safeguarding persons, buildings, dwellings and their contents from hazards arising from the use of electricity for light, heat, power, radio, signaling and other purposes.

1426.03 FILE AND DISTRIBUTION COPIES.

At least one copy of the National Electrical Code, as adopted in Section 1426.01, is on file with the Clerk/Treasurer for inspection by the public. At least one copy of such Code is also on file in the County Law Library. In addition, the Clerk/Treasurer shall keep copies of such Code available for distribution to the public, at cost.

1426.04 CONFLICTS OF LAWS.

(a) In the event of a conflict between any of the provisions of the National Electrical Code, as adopted in Section 1426.01, and a provision of any local ordinance, resolution, rule or regulation, the code approved by the Ohio Board of Building Standards shall control.

(b) In the event of a conflict between any of the provisions of such Code and a provision of State law, the stricter standard shall control.

(c) In the event of a conflict between any of the provisions of such Code and a provision of any other technical code adopted by reference by the Village, the stricter standard shall control.

1426.99 PENALTY; EQUITABLE REMEDIES.

(a) Whoever violates or fails to comply with any of the provisions of this chapter, including any provision of the National Electrical Code, adopted in Section 1426.01, is guilty of a misdemeanor of the first degree and shall be fined not more than one thousand dollars (\$1,000) or imprisoned not more than six months, or both, for each offense. Unless otherwise provided, a separate offense shall be deemed committed each day during or on which a violation or noncompliance occurs or continues.

(b) The application of the penalty provided in subsection (a) hereof shall not be deemed to prevent the enforced removal of prohibited conditions, or the application of any other equitable remedy.
