## Vision Care: Medicare and other Resources

Although Medicare covers many preventative services, coverage has not been extended to routine eye care. Original Medicare (Parts A & B) does not cover routine eye exams, or the purchase of eyeglasses or contact lenses. If you are enrolled in a Medicare Advantage plan, check with your plan to see whether it covers these services/supplies.

The vision care that Part B Medicare does however include is:

- 1. An annual glaucoma test for at-risk individuals. The high-risk group may include: those with diabetes, African-Americans aged 50+, Hispanics 65+ and/or those with a family history of glaucoma.
- 2. An annual exam to test for diabetic retinopathy among diabetics.
- 3. Certain diagnostic tests and screenings for macular degeneration.
- 4. Cataract surgery, plus one pair of post-surgery eyeglasses or contact lenses following surgery. Medicare will only pay for contact lenses or eyeglasses from a supplier enrolled in Medicare.

For each of these covered services, you would pay 20% of the Medicare approved amount, and the Part B deductible applies. Your Medicare supplement assists with all Medicare approved costs. Following resources may assist with vision care/related technology, eyewear and related services and costs:

## 2024 MEDICARE PARTS A & B PREMIUMS AND DEDUCTIBLES

#### MEDICARE PART B PREMIUM AND DEDUCTIBLE

Medicare Part B covers physicians' services, outpatient hospital services, certain home health services, durable medical equipment, and certain other medical and health services not covered by Medicare Part A.

Each year, the Medicare Part B premium, deductible, and coinsurance rates are determined according to provisions of the Social Security Act. The standard monthly premium for Medicare Part B enrollees will be \$174.70 for 2024, an increase of \$9.80 from \$164.90 in 2023. The annual deductible for all Medicare Part B beneficiaries will be \$240 in 2024, an increase of \$14 from the annual deductible of \$226 in 2023.

The increase in the 2024 Part B standard premium and deductible is mainly due to projected increases in health care spending and, to a lesser degree, the remedy for the 340B-acquired drug payment policy for the 2018-2022 period under the Hospital Outpatient Prospective Payment System.

Beginning in 2023, individuals whose full Medicare coverage ended 36 months after a kidney transplant and who do not have certain other types of insurance coverage can elect to continue Part B coverage of immunosuppressive drugs by paying a premium. For 2024, the standard immunosuppressive drug premium is \$103.00.

#### **MEDICARE PART B INCOME-RELATED MONTHLY ADJUSTMENT AMOUNTS**

Since 2007, a beneficiary's Part B monthly premium has been based on his or her income. These income-related monthly adjustment amounts affect roughly 8 percent of people with Medicare Part B. The 2024 Part B total premiums for high-income beneficiaries with full Part B coverage are shown in the following table:

#### MEDICARE PART A PREMIUM AND DEDUCTIBLE

Medicare Part A covers inpatient hospitals, skilled nursing facilities, hospice, inpatient rehabilitation, and some home health care services. About 99 percent of Medicare beneficiaries do not have a Part A premium since they have at least 40 quarters of Medicare-covered employment, as determined by the Social Security Administration.

The Medicare Part A inpatient hospital deductible that beneficiaries pay if admitted to the hospital will be \$1,632 in 2024, an increase of \$32 from \$1,600 in 2023. The Part A inpatient hospital deductible covers beneficiaries' share of costs for the first 60 days of Medicare-covered inpatient hospital care in a benefit period. In 2024, beneficiaries must pay a coinsurance amount of \$408 per day for the 61<sup>st</sup> through 90<sup>th</sup> day of a hospitalization (\$400 in 2023) in a benefit period and \$816 per day for lifetime reserve days (\$800 in 2023). For beneficiaries in skilled nursing facilities, the daily coinsurance for days 21 through 100 of extended care services in a benefit period will be \$204.00 in 2024 (\$200.00 in 2023).

## **COST-OF-LIVING ADJUSTMENT (COLA) INFORMATION FOR 2024**

Social Security and Supplemental Security Income (SSI) benefits for more than 71 million Americans will increase 3.2 percent in 2024. The 3.2 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 66 million Social Security beneficiaries in January 2024. Increased payments to approximately 7.5 million SSI recipients will begin on December 29, 2023. (Note: some people receive both Social Security and SSI benefits).



The maximum amount of earnings subject to the Social Security tax (taxable maximum) will increase to \$168,600.

The earnings limit for workers who are younger than "full" retirement age will increase to \$22,320. (They deduct \$1 from benefits for each \$2 earned over \$22,320.)

The earnings limit for people reaching their "full" retirement age in 2024 will increase to \$59,520. (They deduct \$1 from benefits for each \$3 earned over \$59,520 until the month the worker turns "full" retirement age.)

There is no limit on earnings for workers who are "full" retirement age or older for the entire year.


