

BROOKLYN HEIGHTS POLICE BLOTTER

- 12/1/20 Multiple reports of cars off roadway and spun out due to snow storm. Blown transformer on E. Schaaf; Fire Department on scene; power outage in area. Multiple vehicles on West 8th issued warning citations for parking on street during snow ban and no parking from 3:00 – 5:00 a.m. Report of wires down on E. Schaaf; checked by Fire Department; checked ok. Assisted resident on W. 7th with removing tree from car roof. Advised resident to remove two vehicles from street on West 7th due to snow ban. Assisted several residents with cars stuck in the snow. Notified Service Department of large tree in cul-de-sac on North Street. Assisted semi stuck on Schaaf Lane; travelled downhill in reverse and continued on alternate route. Report of downed lines on W. Schaaf; Fire Department on scene.
