

## BROOKLYN HEIGHTS POLICE BLOTTER

- 03/20/20 Report of two-car accident at West Schaaf and Tuxedo Avenue; same occurred in Cleveland; parties advised to contact Cleveland PD 2<sup>nd</sup> District. Disabled vehicle blocking I-480 E/B ramp; upon further investigation, discovered vehicle struck cement guardrail under Granger Road overpass; operator arrived on scene; accident report taken. Report of suspicious vehicle on Eastview Drive; checked ok.
- 03/21/20 Disabled vehicle on West 5<sup>th</sup>; on its way after jump starting.
- 03/22/20 Report of erratic driver I-480 E/B; checked area; unable to locate. Two males in resident's back yard looking for deer antlers; advised to stay off private property; will comply; same on their way.
